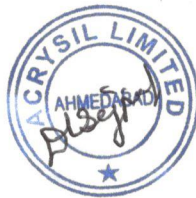

Acrysil had acquired 74% of the share capital in Homestyle Products through its wholly owned subsidiary Acrysil UK .
